After seeing the talent of the young people in our community, attendees are sure to want to bid on quality, professionally framed artwork as well as mingle and dine with other supporters. Proceeds benefit the Court Appointed Special Advocates Program of Summit County (CASA/GAL).

**CASA's mission** is to provide every child who enters the court system as a result of allegations of abuse, neglect or dependency with a trained community volunteer to advocate for what is in the child's "best interest." In 1993, the CASA Volunteer Board Association, Inc. was established to further the mission and support the work of the CASA/GAL Program of Summit County, Ohio. The board partners with the program by raising and administering funds for enhanced programming, personnel support, promoting public awareness of the CASA Program and recognizing the efforts of CASA's heroic volunteers.

## **CASA/GAL Program of Summit County Statistics for 2015:**

- # The CASA/GAL Program of Summit County **served 1,057 children, 589 families.**
- # **274** active CASA/GALs drove over **61,000** miles, volunteering approximately **12,000** hours.
- # **72** new CASA/GAL Volunteers were trained
- # Of the **522** cases that closed in 2015: **30** cases ended with adoption, **224** cases were reunified with parents, and **157** cases were placed with legal guardians.
